## **REGISTRATION INFORMATION**

It is our goal to make Summer Session an opportunity for students to improve their skills and achieve academic success. Therefore, Summer Session classes are intended for credit retrieval for students who earned a D or F during the school year. The only exceptions are Health, American Government, and Personal Fitness I and Personal Fitness II, which are offered online.

### **Class Information:**

- Session 1 – Monday, June 13 – Friday, July 1.
- Session 2 – Tuesday, July 11 – Friday, July 29.
- Class times – 8:00 a.m. – 12:20 p.m. Monday – Friday for both sessions.
- Tuition - \$240.00 for in-district students.
- Tuition - \$350.00 for out-of-district students.
- Because class size is limited, registration is based on a first-come, first-served basis.
- Full payment is required at time of registration. **NO EXCEPTIONS.**
- In the event a class must be cancelled due to low enrollment, a full refund will be given.
- No bus transportation for summer school.

### **Cancellations and Refund Policy**

- Tuition pays the cost of Summer School instructors, staff and maintenance of the program. Once your student is enrolled, there will be no refunds.
- To withdraw a student, you must mail a written request prior to the start of class. A \$25.00 cancellation fee will be deducted.
- Money will not be refunded once class begins.
- Any refund given will be applied to the original method of payment and person on the registration form.
- Refunds require approximately 4 weeks for processing.

## HIGH SCHOOL POLICIES FOR THE 2011 SUMMER SESSION

### ▪ **Summer School Attendance Policy**

- 1.) There are no excused absences.
- 2.) There are no excused tardies.
- 3.) Three (3) tardies equal 1 absence.
- 4.) Once a student accrues two absences (3 tardies equal 1 absence), they will be withdrawn from class – No class credit or refunds will be given.

### ▪ **Summer School Course Selection**

- 1.) Summer classes are semester classes compressed into 60 hours. Grades and class credit are awarded based on completed classroom hours.
- 2.) *All students must consult with their counselor/administrator to select classes, which fulfill district graduation requirements. All registration forms will not be accepted without the counselor's/administrator's signed course credit approval.*
- 3.) One semester of credit and a semester grade will be recorded on your transcript. This grade becomes part of your grade point average (GPA), which determines class ranking in the Cherry Creek School District.

### ▪ **Student Expectations**

- 1.) Cherry Creek School District Policies and Procedures will be in effect during Summer Session.
- 2.) Classroom disruptions of any kind will not be tolerated. Any student violating this policy will be expelled.
- 3.) Summer School will have a 20-minute break from 10:00 a.m. to 10:20 a.m.
- 4.) Summer School will operate as a closed campus.

**Course Descriptions:**

**\*American Government - Online**

American Government focuses on the constitutional principles of the United States republican form of government and how to apply this constitutional knowledge to form an understanding of government and it's relationships on the local, state, national and international levels.

**Grades:** 10-12      **Credit:** .5 (Social Studies, fulfills state civics requirement)      **Prerequisite:** None

**\*Health - Online**

Health focuses on issues and components of personal health as they apply to mental, physical, emotional, and social well-being. Topics include stress management, self-destructive behaviors, sexuality, substance abuse, nutrition, fitness, diseases and others.

**Grades:** 10-12      **Prerequisite:** None      **Credit:** .5 (fulfills District Health Requirement)

**\*Personal Fitness I - Online**

Students in Personal Fitness I will learn about the components of fitness and wellness in order to establish a personal fitness plan that will be implemented throughout the semester. Although this is an online class, the course standards do require students to participate in weekly cardiovascular, flexibility, strength, and endurance exercise. Students will be issued a heart rate monitor to measure their progress and must exercise for 300 minutes (5 hours) a week spread out over at least 4 days in their target heart rate zone (**133 - 173 beats per minute**) in addition to written work and other exercise. **Students are required to attend a fitness-testing session as explained at <http://www.ccsd.k12.co.us/OnlineLearning/summerpolicies.html> .**

**Grades:** 10-12      **Credit:** .5 (Physical Education)

**Prerequisite:** parent permission form (<http://www.ccsd.k12.co.us/onlinelearning/pfpermission.html>). Read and sign the permission slip and attach it to the registration form.

**\* Personal Fitness II - Online**

Students in Personal Fitness II continue to work on their fitness goals and plans developed in Personal Fitness I. Students will be required to participate in weekly cardiovascular, flexibility, strength, and endurance exercise. Students will be issued a heart rate monitor to measure their progress and must exercise for 450 minutes (7.5 hours) a week spread out over at least 4 days in their target heart rate zone (**143 - 173 beats per minute**) in addition to other exercise. **Students are required to attend a fitness-testing session as explained at <http://www.ccsd.k12.co.us/OnlineLearning/summerpolicies.html> .**

**This class cannot be taken concurrently with Personal Fitness I during the summer session.**

**Grades:** 10-12      **Credit:** .5 (Physical Education)

**Prerequisite:** Passing grade from Personal Fitness I and parent permission form (<http://www.ccsd.k12.co.us/onlinelearning/pfpermission.html>). Read and sign the permission slip and attach it to the registration form.

Since the summer academic session is a program sponsored and provided by the school district, all district policies and regulations are applicable to students enrolled in these classes. This letter also serves to inform you of some of the policies and procedures unique to the summer school experience in Cherry Creek.

### **STUDENT CONDUCT**

The Cherry Creek summer school staff will be following relevant school district policy regarding student behavior both in and out of the classroom. Students are expected to pursue the educational program and to behave in such a way that their presence does not detract from their own educational experience or the educational experience of others. Students shall treat teachers, administrators, other district employees and fellow students with dignity and respect. Any student who chooses not to abide by classroom and summer school expectations may be subject to disciplinary action and/or may be asked to leave the program. A parent may be requested to pickup the student immediately from school. A copy of district Policy JICDA, *Conduct and Discipline Code*, is attached referencing specific activities for which a student may be disciplined.

**Please note: In accordance with school district policy and state law, Cherry Creek campuses are designated as "Drug Free Zones." A drug free zone prohibits the use, possession, sale or distribution of a controlled substance. Cherry Creek School District policy also prohibits the use of any tobacco products, as well as prohibiting the possession of use of alcohol on any of the district's premises.**

### **STUDENT ATTENDANCE AND TARDIES**

While District attendance policies are applicable to the summer academic session, the shortened, accelerated summer program requires student attendance be consistent or credit may not be awarded. A student may be removed from the program for excessive absences, whether those absences are excused or unexcused, with no credit awarded and no refunds given. All absences and tardies will be reviewed by the site administrator on an individual basis. If a student accrues more than two (2) absences of any kind, he/she will be withdrawn from summer school and will not receive a refund for any monies paid nor will he/she be granted course credit.


## **CLOSED CAMPUS**

All Cherry Creek summer academic session sites will operate as closed campuses. Any student who leaves campus during the program will be sent home for the remainder of the day and will be assessed an absence. A designated outdoor break area will be available to all students during appropriate break periods. Students participating in the high school summer session will not be allowed to go to their cars during break unless they receive written permission from their teacher or the site administrator. Any violation of this closed campus policy may result in suspension/withdrawal from the summer school program.

The Cherry Creek School District is committed to providing all students with a safe and secure learning environment. The Board of Education has determined that a strict weapons policy is necessary to provide the students and the employees of the school district a safe educational and working environment in and around the schools and facilities, as well as at school-sponsored and sanctioned activities and events. In an effort to ensure all students enrolled in the summer academic session understand the expectations regarding zero tolerance for weapons on district premises, **we ask that you read and sign the Weapons Policy Agreement found on page 15, and return it with your registration form.**

Again, on behalf of the Cherry Creek School District, I welcome your participation in the summer academic session and thank you in advance for your support and cooperation with our policies and procedures which ensure a safe and enriching learning environment for all students. Dear Parent/Guardian:

This letter is to inform you of changes in the school district's procedures regarding Alcohol and Other Drug Use by Students (Regulation: JICH-R). These changes were approved by the Cherry Creek School District Board of Education on Monday, January 8, 2007 and will take effect beginning March 1, 2007. We believe these changes take a strong stand against alcohol and drug use by our students and will help to equip students and their families with needed information, skills and/or intervention to make better choices in the future. Our goal is to increase every student's opportunity to remain healthy, drug-free and available to participate in high quality learning.

Changes include an increase in suspension days to ten (10) days for students at the first offense of the district's Policy JICH, Alcohol and Other Drug Use by Students. This policy addresses the use or possession of any prohibited substance, including alcohol, marijuana, or other controlled substances or counterfeit drugs on campus or at any school sponsored event. The new procedure also allows for a reduction in this suspension time to three (3) days provided the student completes an alcohol or drug education program. The Cherry Creek School District is helping provide access to an alcohol and drug education program that includes participation by parents and/or guardians.

At the second offense of district Policy JICH, Alcohol and Other Drug Use by Students, changes include a 10-day suspension and recommendation for expulsion for serious violation of school board policy. The student may return to school after five (5) days and the recommendation for expulsion may be waived if the student participates in an evaluation/assessment and provides evidence of a recommended intervention plan and intent to enroll in intervention/treatment.

There is no change regarding a third or subsequent violation of this policy or the sale/distribution of alcohol or drugs. A recommendation for expulsion remains the consequence for either of these behaviors.

Dear Parents/Guardians and Students:

The Cherry Creek School District and the Summer Academic Session Staff are committed to providing a safe learning environment for all students enrolled in district summer programs and activities. As part of this commitment to safety, and to ensure compliance with school board policy, you are asked to read and sign the following excerpt from **Policy JICI, Weapons in Schools:**

"The Board of Education has determined that a strict weapons policy is necessary to provide the students and employees of the School District a safe educational and working environment in and around the schools and facilities of the District and at school-sponsored and sanctioned activities and events.

*For the purpose of this policy, the Board of Education has made a distinction between "Deadly Weapon/Firearm," "Weapon," or "Facsimile."*

- **"Deadly Weapon/Firearm"** means any object, material, or substance which in the manner used, designed to be used, or intended to be used, is capable of producing death or serious bodily injury. Examples include, but are not limited to, firearms (whether loaded or unloaded) including BB and pellet guns, destructive devices, including explosive objects such as pipe bombs and grenades, knives, brass knuckles or other objects placed on the fist, nunchakus, spring guns, slingshots, bludgeons, including any instrument of any sort modified or fashioned in such a manner as to be used as a bludgeon, and throwing stars.
- **"Weapon"** means any object which is generally used for nonviolent or nondangerous purposes, but which can be considered a weapon under this policy as a result of its use or intended or threatened use. For example, a baseball bat is not ordinarily considered a weapon; however, when used or threatened to be used to strike the head of another person in a fight, it will be considered a weapon under this policy. Other examples of objects which may, under given circumstances, be weapons include, but are not limited to, rocks, bottles, cans, chains, shoes, softball bats, ropes, and mace and similar noxious chemical substances.
- **"Facsimile"** or replica of a deadly weapon can be considered a weapon under this policy if used in a threatening, intimidating, violent or improper manner. "Facsimiles" are replicas of deadly weapons including any copy, reproduction, model, or other object which is intended to appear like a deadly weapon regardless of the substance from which it is made. Examples of "Facsimiles" include, but are not limited to, water pistols, cap guns, and look-a-likes.
- **"Deadly Weapons/Firearms," and/or "Weapons"**- The possession and/or use of any "Deadly Weapon/Firearm" and/or "Weapon", as herein above defined, by any student, on any District property or at any school-sponsored or sanctioned event, shall require the expulsion of the student involved for up to a full calendar year.
- **"Facsimile"**- The possession and/or use of any "Facsimile", as herein above defined, in a threatening or improper manner, by any student, on any District property or at any school-sponsored or sanctioned event, shall require the expulsion of the student involved. Depending on how the student uses or posses a "Facsimile", he/she may be suspended and/or expelled."

**This letter must be signed and returned with the registration form when registering your child for summer school.** If you have any questions or concerns regarding the Cherry Creek School District Weapons Policy or this Agreement, please feel free to contact the principal at the summer school site.
