<b>What is the overall <u>deductible</u>?</b>	Network: <b>\$6,000</b> Individual / <b>\$12,000</b> Family Per policy year.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your <u>deductibles</u>?</b>	Yes. <u>Preventive Care Services</u> is covered before you meet your <u>deductible</u> . ### Does this plan provide Minimum Essential Coverage? Yes

## Endnotes
