

## PSAT™ 10 AND SAT® SCHOOL DAY

# Student Data Consent Form

The Colorado Department of Education is offering all Colorado public school students in 10th grade a chance to take the PSAT™ 10 and in 11th grade the SAT®. These assessments are aligned to the Colorado Academic Standards and measure the skills and knowledge needed for college and career readiness.

College Board, the provider of the SAT Suite of Assessments, provides a number of structures to support students' and their families' ability to connect to key opportunities available to them. As such, College Board gives students and families complete discretion regarding the additional, voluntary information they disclose beyond the minimum needed to register and score our assessments.

Prior to testing, students taking these exams will participate in a preadministration session to:

- Complete required student information needed for scoring,
- Participate in the optional questionnaire

The required information covers the basics (name, school, state student ID, grade, gender, and date of birth) needed to score your test. If taking the SAT, students also have a chance to choose up to four colleges or scholarship programs to share their SAT scores with for free. Score sends are optional, but we strongly encourage students to share their scores to demonstrate their interest in their chosen schools.

**To participate in the optional questionnaire portion of the preadministration session, students must return this signed consent form.**

The questionnaire asks about you and your interests. This information is used for group reporting, for analysis to ensure the exams are fair for all groups, to connect you with potential colleges or scholarship opportunities, and for research.

A primary benefit of completing the optional questionnaire is to opt in to Student Search Service®, which connects you to college and scholarship opportunities that reflect your interests. If you choose to participate in the optional questionnaire, the data you provide will be added to your College Board student record, even if you choose not to participate in Student Search Service. Also, if you prepare a college list on BigFuture™ we may share that list, or part of

the list, with eligible colleges, universities, scholarships, and other educational programs.

Your responses:

- Give counselors and college admission officers information to help you plan for the future. The more information you give, the more assistance they can give to you.
- Provide information to College Board that is used to ensure the PSAT 10 and SAT are fair and accurate tests for all students.
- Are used by College Board for research and planning to improve tests and services.
- Contribute—when combined with responses of all other students taking the PSAT 10 or SAT—to an understanding of your graduating class. This lets colleges and universities deliver programs and opportunities to serve you and your classmates.

College Board only shares your email address, racial/ethnic group, and answers about coursework (including grade point average), high school activities, and college plans (including college majors) from your answer sheet and your score ranges with eligible colleges, universities, scholarships, and other educational programs that signed a license agreement, by which College Board can consistently monitor these organizations' use of student information for compliance. College Board does not share your telephone number or actual test score as a part of Student Search Service. You may cancel your participation in Student Search Service at any time. To be clear, completion of the optional questionnaire and participation in Student Search Service are **optional and voluntary** for all students. Your teacher will identify the optional questions during the preadministration session, and you will receive instructions again when you complete the questionnaire.

The following information are data elements College Board will receive from either the Colorado Department of Education or a student directly. The information is required and necessary to register, score, and report student results.

### Optional Questions

The following information represents the optional questions. Only students who return a signed consent form will be allowed to respond to the following questions. Students may choose to answer some or all the optional questions. Students may decline to answer a question by leaving it blank.

<b>Home/Mailing Address</b> Mailing address is only required if a student also opts in to Student Search Service. When provided, College Board may contact the student regarding their test, and their address will be added to their student record. <b>Student Search Service</b> Each student taking the PSAT 10 or SAT is asked to respond to the Student Search Service opt-in question (Yes or No response). This question allows a student to choose whether or not to opt in to Student Search Service. This is the only question that is required to participate in Student Search Service. A student cannot be included in Student Search Service unless they opt in to the program. If left blank, College Board will assume a No response unless an opt-in is already on file for the student. In which case, College Board will not change the student's current status.  When a student opts in to Student Search Service and responds to the other optional questions, this allows eligible colleges and universities to find students based on these criteria (for example, based on their intended major or GPA). Some eligible colleges, universities, scholarships, and other educational programs may request information from College Board that students provide in order to inform them of educational opportunities and financial aid. Participating programs will receive a list of students who scored within a specified score range, but will not receive individual student scores from any College Board assessments through Student Search Service. <b>Email Address</b> Email address is optional. If provided, it will be used to provide reminders about SAT test dates registration deadlines, test-preparation strategies, score availability, and added to a student's Student Search Service record if the student opted in to this service. If a student provides a parent's or guardian's email, it will only be used by College Board to provide updates on test programs.	Optional	Optional
<b>Mobile Number</b> If mobile number is provided, the student agrees to receive text messages from College Board about a test program for which they are registered, about participating in research surveys, and/or about receiving free college planning services.	Optional	Optional
<b>Racial/Ethnic Group</b> Students are asked if they are of Hispanic, Latino, or Spanish origin and to specify their race. For Colorado school-day testing, this information is provided by the state.	Optional	Optional
<b>Language Background</b> Students are asked which language was their first spoken and what language they know best.	Optional	Optional

<p><b>High School Activities</b> Students are asked which activities and programs they are interested in participating in in college, including extracurricular activities, arts and music, and sports. Students can make multiple selections.</p>		Optional

<p><b>Grade Point Average (GPA)</b> Students are asked to estimate their high school grade point average.</p>	Optional	Optional

<p><b>Coursework</b> From a list of common high school courses in Math, Science, Languages, English/Language Arts, and Social Studies, students are asked to indicate what grade level they completed or plan to complete each class, and indicate if they took an honors, Advanced Placement®, or dual enrollment course in the subject.</p>		Optional
