Dear Community Member,

On March 3, 2021, the Long-Range Facility Planning Committee (LRFPC) of the Cherry Creek School District met to finalize the boundary recommendation for Elementary #45. The attendance boundary information was reviewed and a recommendation was made to the District Leadership Team, who in turn made the final recommendation to the Board of Education. The purpose of this letter is to inform you of the final boundary decision.

Boundary Scenario B (as shown on the back of this letter) will be effective for the 2022-23 school year when Elementary #45 opens. The recommendation was submitted as information to the Board of Education at their monthly meeting on April 12, 2021. This same information was put forward as a Resolution to the Board of Education and subsequently was adopted at their monthly meeting on May 10, 2021.

If you live within the boundaries identified on the reverse side of this letter, your student will automatically be assigned to Elementary School #45 for the 2022-23 school year. Serenity Ridge families who would prefer their children attend Black Forest Hills Elementary **will be accepted** on a School of Choice or IntraDistrict transfer request. If your child is currently completing 3<sup>rd</sup> grade at Altitude Elementary they may remain at Altitude for their 5th grade year with transportation provided by the District. **To take advantage of this option, you must complete and submit an online School of Choice request during the month of January 2022.**
